Talking about her experiences. So well and the fact that she has given least some momentum, it would seem is a good vote. So sending your votes, by all the means of communication for your person of the years. Not I'm going to be the most scientific survey, I would hasten to add. But yeah, let's hear what you think but of course, so while that's going on, we'll talk about, let's sa first, the really good news. And that is it sort of got through Parliament in state of Victoria.

State parliament in a rush on Thursday into Friday. With some late, sitting out some system to a commercial station this morning where one reporter had to be there all night and do the proverbial cat naps when the debate was a bit quiet, but as well as the pandemic laws, which is an issue, perhaps Beyond this program, the ending of religious

discrimination. Just the allowance of religious discrimination in a number of settings. Particularly schools. Got through the Victorian Parliament.

And so this is incredibly, welcome. Of course, from the point of view of a lot of lgbtiq A+people and we should acknowledge that Tasmania has had such laws for a very long time since 2005 and well done to them of course. And, you know, the seems that some of the, the people some archbishop's down there or something, had a bit of a hissy fit and did.

Like it, which was part of the reason for the federal law and that was proposed and we'll talk about in a second. But this Victorian law passing is very, very welcome. And now for the meantime, it, of course, will be in in force, which is incredibly, welcome. And the reason I say in the meantime, I mean, I'll come to that linking it to the federal law in a second, but you can to find out about this. Good news. Look at a web and

Email on Premier dot Vic dot gov dot you sorry immediate release. Well, it's all technology to this person who remembers telegrams and the answer is labor. Government has sent a strong message that there is no place for discrimination in Victorian schools and workplace with laws passed in Parliament on the 3rd of December and under the Equal Opportunity, religious exceptions Amendment act, religious organizations, and schools will no longer be able to Sack or refuse to hire people based on protected attributes such as sexuality, gender identity, or marital.

Itís and religious organizations and schools will only be able to make employment decisions based on where an employee's beliefs are inherent to the job such as a religious studies teacher or a principal. Now, let's just stop there. Stop quoting for a second. Why does the gardener need to be a Catholic in a Catholic school or Jewish in a Jewish school? And where does this end? I mean, let's say I'm a trans person who I have a job as a career and I turn up to the school to they then said well, we don't want you in here because you might influence the children. Yeah, well

Yes end. Yeah, make sure I'm not hired but if I'm A supplier or a contractor that sort of thing. So the bill recognizes the right of religious organizations and schools to continue to practice their faith, provide religious teaching and still their ethos. But the organize legislation will on impact on how religious bodies select priests ministers religious

leaders or their members perfectly fair. So the religious organizations that receive Victorian Government funding to provide services, will not be able to

To refuse to provide services based on sexual orientation, or gender identity and the this release. And I'm only quoting it quote previous protections to prevent discrimination against LGBT IQ. People were shamefully stripped back in 2011 by the former liberal government and were also blocked by the Liberals from being reinstated in 2016. So this now means that, you know, Igbti I'm going to say Igbtqa.

Plus teachers, there's a little lack of clarity on sex characteristics / intersects. So, but the thing is, you will be able to be out as a teacher or student, which will be enormous and, you know, sort of, I think be of great benefit. So well done to Victoria joining Tasmania, and let's hope other states and territories where these reforms are needed on the large island. If we can call the of course, at will follow suit.

So we move up north to Canberra, where the federal law of water. An interesting week. It has been there. And well, the religious discrimination bill has now been sent off to, to not just one. But, two enquiries then it's all a little, a little from my research thus far, A little, not quite 100% clear. So the bills it would seem that had the

Movement tried to force the bills through and get an actual vote on accepting the bills in their status, that some moderate liberals would have voted against it. People like Trent Zimmerman Zimmerman and possibly Warren inch, possibly others. And that is worth noting. So there's now two inquiries, there's a for the religious discrimination Bill 2021 and related bills. The attorney general has referred.

Third to abjure parliamentary joint committee on human rights. The matters for inquiry and report by the 4th of February, 20 22, and they are referred to as the religious discrimination legislative package. This is on a pH dot gov dot EU parliamentary business committees joint / human rights, / religious discrimination. I took me a while to find it. I can tell you and the committee had resolved, it will carefully consider all correspondence received including from

committee has developed an online survey to allow members of the public to express their views and that will close at 5:00 p.m. On the 21st of December 20, 21. So, you have 16 days to put your views. It now. I started looking through it this morning and make sure you get to the question where about if you oppose the bill or whether you don't whether you support.

It, the critical one is whether you support or oppose the bill in its current form because some of the questions are the sort of a bit could be considered a bit push polling. Let's go through it now. I'll put in some answers. Nope. It's gone back to where I left it this morning. So, starting at question 1, which is almost a logical thing to do. The questions are and I quote as we keep hitting previous live.

Here. Do you believe they should be legislation to protect people from religious discrimination certain areas of public life of on the Barons of their religious belief or activity. This will include protecting people who don't hold a religious belief. Well, it's kind of hard to argue with that, but it's sort of what it doesn't say and how the devil the pun intended the devils in the detail. Then it says we currently have a sex age, racial discrimination act. You think it's also important to have a religious Discrimination Act as well.

We also have a disability Discrimination Act so that there's a bit of a tricky one, but then we get two part. Question, 3, do you support the religious discrimination legislative package? That is currently before the Parliament and on it goes. So make sure you keep going. Do you believe parents should be able to send children and choose to send children to a choice School of their choice which aligns with their religious values. Well, is that a loaded question? Possibly should parents shouldn't

It's do what's right for their child. Do you believe that religious schools should require all students to practice their religion affiliated with this this school. If the requirement is necessary to avoid injury to the religious susceptibilities of people of that religion, what about the people who aren't do you believe schools, hospitals, aged care facilities? Accommodation disability. Service providers, should be be able to preference. The hiring the staff of the same religious beliefs so long. As this is in accordance with a publicly available written policy. Well, what if you are religious and you can't

Get the stuff. I mean, the Jewish population is .4 of one percent of the population. If you're a Jewish service provider, why would you want to do it? Religious charity should be able to preference persons who share their religious beliefs would making employment decisions. Religious people comfortable should be, would be comfortable to share their beliefs in public life without the religious discrimination Bill. Well, it seems a lot of fundamentalist Christians are, so they are at the moment. Do you believe it should be lawful to make a statement of beliefs?

Only has made his good faith and not malicious, threatening intimidating or harassing. And who decides what that is according to her to what circumstances. And finally it says should the committee choose to publish anonymized representative sample. The response is due to Greed apart of all of your responses being published and then it asks for your details. So it's I think that's it. I have to go with my gut. I feel that's pretty push polling to use the term loaded questions. Call it what you will.

But obviously, the critical one is that one about the religious. Yeah, sort of the bill, the package in its current form, which is clearly doubtful. So that's one inquiry and that's the joint select inquiry and then we have this one, the Senate legal and constitutional Affairs inquiry which doesn't give us a lot of information and it's just as for inquiry and report by the 4th of February 22 on this.

Eleven page.
